

A NON - UTILITY MAXIMIZATION APPROACH TO MULTIPERIOD PORTFOLIO SELECTION

It is proposed to determine a portfolio based on two conditions. First, there should be no arbitrage opportunity. Second, the portfolio valuation should support a given preference for the growth of the portfolio value. It is shown that a portfolio satisfying these conditions exists under reasonable assumptions.
