### **Submission: Academic Sessions - Conference**

Authors are required to submit two copies of the completed paper in pdf format; one with authors' details and the other without authors' details. **Ideally, each author will present one paper at the conference.** If you have submitted more than one paper and multiple papers are accepted by the selection committee for presentation, please ensure that a co-author is available and willing to present the other paper(s) at the conference.

Authors of the accepted papers are expected to act as a discussant in their chosen field of expertise. Please select at least two areas of expertise when you submit your papers. If your paper is accepted and if you do not select your areas of expertise, the conference chair, at his discretion, will assign you papers to serve as a discussant.

Optional inclusion in conference proceedings - preference must be specified during the online submission process.

### **Selection Process of Conference Awards - Academic Sessions**

#### **2-Stage Blind Review**

Please indicate at the time of submission if you would like your paper to be considered for one of the awards. **You can choose only one award category.** For each category, a panel of

three experts from the program committee will assess the papers to finalize the decision for the conference best paper award. Authors should submit the final (blind) version of their paper on or before **15 Feb 2020** with the registration fees for the assessment of the award.

### Conference Academic Sessions – Important Dates

- Submission must follow the procedure outlined on the website.
- The deadline for submitting papers and consideration for the awards is **15 December 2019**.
- Acceptance of papers will be notified on **15 January 2020**.

### PhD SYMPOSIUM

The PhD Symposium will provide PhD students with an opportunity to present their proposal or working papers and receive expert feedback on their work. The Symposium will also enable students to interact and network with eminent researchers from universities across the globe.

#### PhD Research Proposal Submission

- Submission of Abstract (Maximum 500 words) of the PhD research proposal in pdf format **MUST** be submitted through the conference website by **15 December 2019**.
- Acceptance of PhD proposal will be notified around **15 January 2020**.
- A full proposal or research paper is to be submitted on or before **15 February 2020** with their registration fees for the assessment of the award.
- Each paper or PhD proposal of PhD students will be discussed by a senior academic at the PhD symposium.
- Only complete proposals or research papers are considered for an award.

#### Eligibility

- PhD Students who have successfully passed their PhD confirmation.
- Ideally, students will have a draft of their first/core empirical chapter and a clear plan for their yet to be completed dissertation.
- Limited places are available for those who have not yet completed one year in their program, but are well advanced in developing their research ideas.

#### Selection Process for PhD Symposium Awards

- Only complete research papers submitted by **15 February 2020** are considered for an award. Submission must follow the submission procedure outlined on the website. Members of the PhD symposium committee will assess all research proposals on the basis of their rigor, relevance and potential contribution to the literature.
